1. INDIA has received a loan from the Asian Development Bank (ADB) toward the cost of Kolkata Environmental Improvement Investment Program – Tranche 1 under the contracts named above. Bidding is open to bidders from eligible source countries of ADB.
2. Bidders may bid for one or several contracts, as further defined in the Bidding Document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Bid Submission Sheet.
3. National Competitive Bidding will be conducted in accordance with ADB's Single Stage Two Envelope Bidding procedure and is open to all bidders from eligible countries as described in the Bidding Document.
4. Interested Bidders may obtain further information from the Purchaser and inspect the Bidding Document at the address given above.
5. The Bidding Document in English language, may be purchased by interested Bidders by writing to the address below and upon payment of a nonrefundable fee of **INR. 6,000/- (Indian Rupees Six Thousand only)**, from the date of publication of the advertisement upto the last date of submission of Bids. Those who desire to receive the document by

courier shall pay **INR 500/- (Indian Rupees Five Hundred only) extra for delivery within India.** The fee shall be paid in the form of demand draft favoring “**The Kolkata Municipal Corporation, A/c KEIIP, Tranche-1**” payable at Kolkata.. No liability will be accepted by The Purchaser for loss or late delivery.

6. Bidders should satisfy the following qualification requirement :

The bidder/supplier must have successfully completed 3 contracts as main supplier within the last 3 years. Value, nature and complexity of these contracts should be comparable to the contract to be let.

- The bidder/supplier must be in the business for supply of hardware and networking services including software development for at least last three years.
- Bidder shall possess experience in supply and installation of hardware and networking components related to services.
- Bidder shall have experience in software development and Integrated Database system.

7. Bids must be delivered to the address above on or before **2.30 P.M. Indian Standard Time (IST) on 17.08.2016.** All bids must be accompanied by a Bid Security as described in the Bidding Document. Late bids shall be rejected.

8. Technical Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address above immediately after bid submission. At the end of the evaluation of Technical Bids Purchaser will invite technically qualified bidders to attend the opening of the Price Bid at the date and time determined.

9. Pre bid meeting shall be held in the office of the Project Director, KEIIP at **11.00 . A.M. (IST) on 20.07.2016.** Bidders are encouraged to participate in this meeting and it is desirable that bid documents are studied thoroughly by the bidders before this meeting. Non- attendance at the pre- bid meeting will not be a cause for disqualification of a bidder.

10. The Kolkata Municipal Corporation (“the Purchaser”), will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of Bids.

11. Delivery Period: The goods/services shall be delivered and services completed within a period of 7 **(Seven) months.**
