Part of this loan will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.

The **Kolkata Municipal Corporation** (“the Employer”) represented by the Project Director, **Kolkata Municipal Corporation – Sustainability, Hygiene and Resilience Project (KMC-SHARP)**, invites eligible bidders to submit bids online in the e-Tendering platform of the State Government of West Bengal (URL: <https://wbtenders.gov.in>) for the — Development of S&D Network in Julpia Catchment (Part of Ward 142) including Construction of Julpia Pumping Station in Borough XVI (The Works) and the principal quantities involved, but not limited to, are:

3. **Open Competitive Bidding (national advertisement)** will be conducted in accordance with ADB's [Single-Stage: Two-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
- Average Annual Construction Turnover (AACT) for the last three (3) financial Years: equal to or more than INR 1140.00 million
  - Experience in completion of at least one (1) similar type of the following works with a contract value of INR 1200.00 million, in the last seven (7) years, before the date of bid submission OR Experience in completion of at least two (2) similar types of the following works with a contract value of INR 800.00 million, in the last seven (7) years, before the date of bid submission.
    - Supply and laying of RCC /DWC/DI Sewerage /Drainage Pipe – 300 mm dia minimum by Open cut method – 4.8 km.
    - CC TV Survey work of assorted dia of RCC sewer of 4.8 km
    - Supply and laying of minimum 1000 mm dia RCC Sewerage /Drainage Pipe by Microtunnelling method – 0.9 km
    - Road Restoration Works for 24500 sqm
    - Construction of one Pumping station including Pumpsets
    - Operation & maintenance of Sewerage / Drainage/ Water Supply Pumping station
  - Must demonstrate availability of financial resources (less its financial obligations for current contract commitments), meets or exceeds the total requirement for the subject contract, as detailed below:
    - Sole Bidder: INR 145.00 million
    - For JV: One Partner must meet or exceed INR 58.0 million
    - For JV: Each Partner must meet or exceed INR 36.25 million
- The combined financial resources of the Joint Venture must meet or exceed the total requirement for the Subject Contract of INR 145.00 million
