Part of this loan will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Kolkata Municipal Corporation** (“the Employer”) represented by the Project Director, Kolkata Municipal Corporation - Sustainability, Hygiene And Resilience Project (KMC-SHARP), invites eligible bidders to submit bids online in the e-Tendering platform of the State Government of West Bengal (URL: <https://wbtenders.gov.in>) for the —Development of S&D network in Adjoining areas in Sonamukhi main Road and Kastodanga Road in Suti Sub basin (Part of Ward 127) in Borough XIV (The Works) and the principal quantities involved, but not limited to, are:

4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
  - Average Annual Construction Turnover (AACT) for the last three (3) financial Years: equal to or more than INR 685.00 million
  - Experience in completion of at least one(1) similar type of the following works with a contract value of INR 715.00 million, in the last seven (7) years, before the date of bid submission: {OR Experience in completion of at least two (2) similar types of the

*following works with a contract value of INR 480.00 million, in the last seven (7) years, before the date of bid submission:}*

- Supply and laying of RCC/DWC pipe of size 300 mm and above – 4.2 km.
- Road restoration work for 34,000 sqm.
- CCTV Survey work of assorted dia of RCC sewer of 4.2 km
- Must demonstrate availability of financial resources (less its financial obligations for current contract commitments), meets or exceeds the total requirement for the subject contract, as detailed below:
  - Sole Bidder: INR 85.5 million
  - For JV: One Partner must meet or exceed INR 34.2 million
  - For JV: Each Partner must meet or exceed INR 21.38 million
  - The combined financial resources of the Joint Venture must meet or exceed the total requirement for the Subject Contract of INR 85.5 million.
